Sylvia announced that Founders' Day will be celebrated by the Alumnae Group with the usual formal dinner dance, which probably will be held Saturday, February 23, at the Edgewater Beach Hotel, Alice Neilsen and Claribel Hurdle having charge. She asked Madge to appoint an active member to assist, so Hazel was placed on the Committee.
